DISTRICT

Located in South Dublin, the Sandyford Business District comprises Sandyford, Stillorgan, Central and South County Business Parks - the name was formally adopted in September 2011 by Dun Laoghaire Rathdown County Council (DLRCoCo) in the Sandyford Urban Framework Plan.

ASSOCIATION

Committee:

The SBDA committee is made up 15 business people, representing the four business parks, who give their time voluntarily. Committee meetings are held monthly with various sub-committees and project teams convening regularly on different topics in addition to frequent meetings with key stakeholders, in particular DLRCoCo. Background:

In 1996, when the development potential of the area was first recognised and harnessed, the original association was created from the combination of representative bodies of individual business parks formed in previous decades.

In November 2011, the association ratified the change of name to Sandyford Business District Association to properly reflect the progressive and vibrant District which the area has become.

INFRASTUCTURE

South County Business Park: Interim upgrade at Leopardstown Roundabout providing a slip lane exit from SCBP to M50

Burton Hall Road Extension: opened in January 2014 linking Burton Hall Road to Leopardstown Road (opposite Bewleys) providing a new entrance and exit to and from the M50 alleviating congestion approaching the Leopardstown Roundabout

Leopardstown Roundabout Reconfiguration & Link Road: lobbied for and approved by An Bord Pleanala in 2013 with construction planned to commence in June 2014.

New Pedestrian Boulevard: creating a link from Blackthorn Drive to Carmanhall Road – lobbied for and delivered in Spring 2013

Two way system on Blackthorn Road: introduced in 2013

Smarter Travel Scheme: launched by DLRCoCo in 2012

Pedestrian & Cycle Route old Harcourt Street Line: linking Leopardstown Road & Brewery Road, lobbied for and delivered in Autumn 2012

Leopardstown & Brewery Roads Signalised Crossings: for pedestrians and cyclists launched in 2012

Park & Ride in Carrickmines: lobbied for and delivered in Spring 2012

St. Benildus Avenue: connecting Blackthorn Avenue to Drummartin Link Road lobbied for and delivered in Autumn 2011

Traffic Lights at ESB Roundabout: lobbied for and delivered in Autumn 2011

INVESTMENT & PLANNING

"Invest in Sandyford" Project: To promote the Sandyford Business District as an established world-class investment location of choice for both international and domestic audiences, grants have been awarded under the DLRCoCo Business Grant Scheme to fund marketing collateral including: a promotional video, website & social media etc. In addition, further funding has been granted towards a "Gateway to Sandyford" event in 2014 to market the Sandyford Business District to the IDA, Enterprise Ireland, Property Agents, Connect Ireland and other stakeholders to generate interest from investors.
