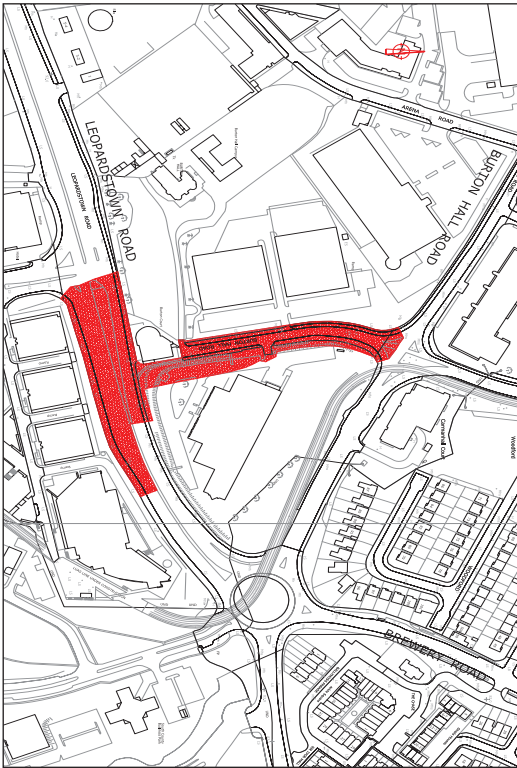

Dún Laoghaire-Rathdown County Council has on the 9th July 2012 made a Confirmation Order confirming the above-named Compulsory Purchase Order as respects the land described in the Schedule hereto. The said Order, as so confirmed, authorises The County Council of the County of Dún Laoghaire-Rathdown to acquire the said land compulsorily. It will become operative three weeks from the date of the publication of this Notice. A copy of the Order as so confirmed and of the map referred to in it may be seen at the Offices of:

An application for Judicial Review of the decision of the Council under Order 84 of the Rules of the Superior Courts (S.I. No. 15 of 1986) may be duly made to the High Court within eight weeks of the date of publication of this Notice in accordance with Section 50 of the Planning and Development Acts, (2000 - 2011), and all acts amending and extending the same and as substituted by Section 13 of the Planning and Development (Strategic Infrastructure) Act, 2006.

Lands comprising Plots 1.1 – 1.5 at Burton Hall Road southward from the junction of Burton Hall Road/ Blackthorn Avenue to a new junction on the Leopardstown Road west of the Brewery Road roundabout, a distance of 210 metres or thereabouts, situated in the Townlands of Carmanhall in the Administrative area of Dún Laoghaire Rathdown County Council.

Lands comprising temporary Plot 1.2T at Burton Hall Road southward from the junction of Burton Hall Road/ Blackthorn Avenue to a new junction on the Leopardstown Road west of the Brewery Road roundabout, a distance of 210 metres or thereabouts, situated in the Townlands of Carmanhall in the Administrative area of Dún Laoghaire Rathdown County Council for the purpose of the construction of the accommodating works.
