Having viewed the contents of the draft budget 2012 the Sandyford Business District Association are extremely disappointed to note that it is planned not to reduce the rates multiplier for 2012. The Association are surprised to learn this as previous indications were that the rate would be reduced for 2012. The Association believes the proposal not to reduce the rates multiplier for 2012 should not be passed.

The association would like to point out that the local Authorities in Dublin are all proposing reductions in their ARV's for 2012. Dublin City are currently proposing a 1.7% reduction, Fingal a 2% reduction and Dublin South a 2.4% reduction, therefore, we are losing further ground to the Fingal County Council and South Dublin on a competitive front. The Association is concerned that this will make it increasingly difficult to attract new businesses to Sandyford and also to retain the existing businesses and employment numbers in the area.
